2. The Club Chief Training Officer and Captain should be proactive in selecting candidates to attend this course.
3. Branch Office will confirm back with Club the acceptance of registration once the course is full.
4. In the event of the course being fully booked (maximum numbers is 20 per course), priority will be given to Clubs with low trainers to new member ratios, with a maximum of 3 places for any one club.
5. Branch Office will contact the eligible participants directly and provide all course joining instructions and resources for the required pre-course work.
6. Club is **NOT** required to create an Assessment request in Surfguard for this course. This will be actioned by the Branch Office at the completion of the course or once the Candidate is assess as competent.

Is this course for me?

This course has been designed to maximise the amount of time participants have to practice and receive feedback on their skills in a safe learning environment. As such, this course would be ideal for those starting out as a trainer with little previous presentation or training delivery experience. It would also be ideal for those with some informal presentation/training experience who are keen to develop their skills and utilise them to support training within their Club and/or Branch.

To commence training for the Training Officer Certificate you must meet the following course prerequisites:

- be at least 16 years of age on the date of final assessment;
- be proficient in the award in which you wish to train; and

Note: To become an endorsed Training Officer, you need to have held the award that you wish to train for a minimum of 12 months (except in exceptional circumstances – speak to Branch Education Manager for further guidance).

What will I learn?

After completing the pre-course learning and 4 session course, you will be able to:

- Locate the policies, procedures and resources relating to Education in Surf Life Saving NSW
- Identify learning needs of the participants and the organisation
- Design training using a range of appropriate learning activities
- Deliver training using effective communication techniques
- Evaluate training to ensure continuous improvement

Course Details

The aim of this course is to provide participants with the skills and knowledge to confidently deliver Surf Life Saving awards to new and existing members. The course will be highly interactive, providing participants with the opportunity to practice their own skills in session planning, training delivery and course evaluation in a safe learning environment.

Participants will be required to complete around 4-6 hours of pre-course learning, details of which will be provided in the coming days and prior to the start of the course. Pre-course learning will include reading through the Learner Guide, watching instructional videos on YouTube, completing

some written questions and planning for a skill demonstration and two training sessions to be delivered on the course.

You will need to bring along to the training course:

- Your completed Pre-course Workbook
- A laptop or iPad to access SLSNSW resources online and (if you wish) tweak session plans/visual aids for your presentations/skill demonstrations
- Presentations may be recorded, enabling participants to review their own presentation style following the course through the eyes of a learner.

Participants who successfully complete the course requirements will leave the course as a probationary trainer, having achieved the following nationally recognised units of competency:

- TAEDEL301 Provide work skill instruction
- BSBCMM401 Make a presentation

The knowledge and skills learnt on this course are **highly transferable** outside of Surf Life Saving.

Becoming an endorsed Trainer

Following successful completion of this course, probationary trainers are required to deliver a minimum of two courses under the supervision of a mentor before being endorsed by the Branch as a Training Officer. The aim of this process is to ensure that you are comfortable with the course content, the assessment criteria, and with the administrative processes required.

Before you attend this course (or shortly after it), the Branch Education Manager will ensure that you have been allocated a mentor and that you have two courses in the diary to be mentored at.
