BY-LAWS

BY-LAW 1 DUTIES OF OFFICERS

Constitution and By-Laws.

1.1	President
1.1.1	Shall preside at all meetings of the SLSS Council and functions held by SLSS;
1.1.2	Shall have a deliberative and casting vote;
1.1.3	Shall be responsible for ensuring that all office bearers perform their duties in accordance with the
	Constitution and By-Laws of SLSS;
1.1.4	Shall be an ex-officio member of all Committees (except Judiciary Committee) formed under the

1.1.5 Shall be the Delegate to Surf Life Saving New South Wales meetings

1.2 Deputy President

- 1.2.1 Shall assume the role of the SLSS President in their absence;
- 1.2.2 Shall represent the SLSS President and do all things necessary at SLSS Council and SLSS BOM meetings and other functions in their absence.

1.3 Director of Administration

- 1.3.1 Shall in the absence of a Chief Executive Officer being employed by the Branch, be the Public Officer for the purposes of the NSW Incorporations Act.
- 1.3.2 Be responsible for maintaining a register of the names and addresses of all members in whom the control of the Branch is vested.
- 1.3.3. Compile an agenda paper for Branch meetings and must ensure the taking and storage of minutes of such meetings.
- 1.3.4. Be responsible for the forwarding of notices of all meetings and the business to be transacted thereat to members in accordance with the Constitution.
- 1.3.5. Conduct the correspondence of the Branch and be responsible for the custody of all documents belonging to the Branch and for the disposition thereof.
- 1.3.6. Be responsible for the drafting of the Annual Report, arrange for its printing and circulation to all Branch Officers and to Club Secretaries.
- 1.3.7 Be an ex-officio member of the Constitution Committee and the Life Membership and Honours Committee.
- 1.3.8. Distribute authorised communication in accordance with clause 20.

1.4 Director of Finance

- 1.4.1 Shall ensure that all money due to SLSS is collected and received and that all payments authorised by SLSS are made;
- 1.4.2 Shall ensure that correct books and accounts are kept showing the financial affairs of SLSS including full details of all receipts and expenditure connected with the activities of SLSS;
- 1.4.3 Shall cause all money to be lodged to the credit of SLSS at the approved financial institution;
- 1.4.4 Shall at least monthly and at other times as required, prepare financial statements showing details of receipts and expenditure and particulars relating to accounts payable since the previous statement together with bank passbooks and statements reconciling the balance shown therein with the balance as shown on the cash book;
- 1.4.5 Shall prepare accounts of SLSS if and when requested by the BOM or a SLSS Council meeting;
- 1.4.6 Shall once in every year prepare a statement of income and expenditure together with balance sheet showing the financial position of SLSS as at the date of the close of the financial year and arrange for presentation to the auditors for audit;
- 1.4.7 Shall maintain an inventory of all assets of SLSS;
- 1.4.8 Shall arrange insurance on assets and for all risks that SLSS may require.

1.5 Director of Lifesaving and Rescue Services

- 1.5.1 As minimum, shall hold Surf Lifesaving awards Certificate II in Public Safety (Aquatic Rescue) (Bronze Medallion) and Silver Medallion Beach Management or equivalent; Rescue Services experience and time served on LSEC or LRSC is desirable. Should have a minimum of 7 years patrolling experience.
- 1.5.2 Shall ensure the implementation of all SLSA and SLSNSW policies relating to lifesaving.
- 1.5.3 Shall ensure Clubs develop and implement effective Beach Management Plans;
- 1.5.4 Shall oversee the management of Rescue Services

- 1.5.5 Shall ensure effective management of the Lifesaving and Rescue Services Committee in all of its operations and chair its meetings as well as chair any other appropriate meetings relating to Lifesaving and Support Operations as required.
- 1.5.6 Shall prepare monthly reports for presentation and approval at BOM and SLSS Council Meetings and represent the Lifesaving and Rescue Services Committee at such meetings;

1.6 Director of Education

- 1.6.1 As minimum, shall be a current Trainer and Assessor holding a Surf Lifesaving Award and shall hold a Certificate IV Training & Assessment or a relevant degree qualification. Should have minimum of 5 years experience in managing adult teams in the workplace and high level communication skills.
- 1.6.2 Shall prepare monthly reports for presentation and approval at BOM and SLSS Council Meetings and represent the Education Committee at such meetings.
- 1.6.3 Shall ensure effective management of the Education Committee in all of its operations and chair its meetings as well as chair any other appropriate meetings relating to Education as required
- 1.6.4 Ensure SLSS Education matters complies with and aligns with the Branch Strategic Plan.
- 1.6.5 Maintain a close liaison with relevant officers from within the levels of SLSA and external agencies to ensure that best practice in relation to education is maintained.
- 1.6.6 Manage the recruitment, selection, training and performance of SLSS Education Team.
- 1.6.7 Be prepared to attend relevant meetings as requested and submit reports and recommendations to those meetings as necessary.
- 1.6.8 Ensure that the Branch Education structure meets the needs of the Branch.
- 1.6.9 Work with Branch President, Club Presidents, the Education Committee, Chief Instructors and SLSNSW Academy Support Officers to develop a Branch Education Development Plan using outcomes from Club sustainability process, Educheck process, Trainer, Assessor & Facilitators (TAFs)
- 1.6.10 Ensure attendance at annual State Education Meeting and at state Education teleconferences, as required.
- 1.6.11 Ensure that new TAFs are inducted into their role through the mentoring process.

1.7 Director of Surf Sports

- 1.7.1 Shall as a minimum be a currently accredited Surf Sports Official.
- 1.7.2 Shall ensure implementation of all SLSA and SLSNSW policies relating to surf sports;
- 1.7.3 Shall arrange carnival venues and dates annually;
- 1.7.4 Shall ensure effective management of the Surf Sports Committee in all of its competition operations;
- 1.7.5 Shall oversee security and maintenance of all competition equipment.

1.8 Director of Member Services

- 1.8.1 Shall be responsible to the SLSS Council for the conduct and co-ordination of all matters pertaining to member services activities:
- 1.8.2 Shall convene and preside over a Standing Committee established under these By-Laws to be known as the Member Services Committee;
- 1.8.3 Shall prepare monthly reports for presentation and consideration at SLSS BOM and SLSS Council Meetings.

1.9 Director of Youth and Junior Development

- 1.9.1 Shall be responsible to the SLSS Council for the conduct and co-ordination of all matters pertaining to Youth and Junior Development;
- 1.9.2 Shall convene and preside over a Committee established under these By-Laws to be known as the Youth and Junior Development Committee;
- 1.9.3 Shall prepare monthly reports for presentation and consideration at SLSS BOM and SLSS Council meetings.

BY-LAW 2 STANDING COMMITTEES AND SUB-COMMITTEES

2.1 Branch Standing Committees

The Standing Committees, which shall be elected each year at the Annual Election Meeting of SLSS in accordance with the qualifications stated in these By-Laws, shall be:

- 2.1.1 The Lifesaving and Rescue Services Committee (LRSC)
- 2.1.2 The Education Committee (EC)
- 2.1.3 The Surf Sports Committee (SSC)
- 2.1.4 The Member Services Committee (MSC)
- 2.1.5 The Youth and Junior Development Committee (YJDC)

- 2.1.6 The Judiciary Committee A panel of 15 who will convene when required (5 to form quorum).
- 2.1.7 The Constitution Committee 3 to be elected plus Director of Administration/CEO (2 to form quorum).
- 2.1.8 The Finance and Compliance Committee (FACC) 4 to be elected plus Director of Finance (3 to form quorum).
- 2.1.9 The Life Membership and Honours committee of 4 to be elected plus Director of Finance (3 to form quorum), as well as associate members.
- 2.1.10 Selection Committee 4 to be elected plus Director of Surf Sports (3 to form quorum).

2.2 Lifesaving and Rescue Services Standing Sub-Committees

- 2.2.1 Rescue Services Group Sub-Committee
- 2.2.2 Patrol Tribunal Sub-Committee
- 2.2.3 Lifesaving Sub-Committee

BY-LAW 3 MEETINGS OF STANDING COMMITTEES AND SUB-COMMITTEES

- 3.1 Oral or written notice of a meeting of Standing Committees and Sub-Committees shall be given to each member of the Committee at least 48 hours (or such period as may be unanimously agreed upon by the members of the, Standing Committees and Sub Committees) before the time appointed for the holding of the meeting.
- 3.2 Notice of a meeting given under clause 3.1 shall specify the general nature of the business to be transacted at the meeting.
- 3.3 No business shall be transacted by a Standing Committee and Sub Committees unless a quorum is present and if within 30 minutes after the time appointed for the meeting a quorum is not present the meeting stands adjourned to the same place and at the same hour of the same day of the following week
- 3.4 If at the adjourned meeting a quorum is not present within 30 minutes after the time appointed for the meeting, the meeting shall be abandoned.
- 3.5 Unless otherwise stated, a quorum shall be when one third of voting members are present.

BY-LAW 4 LIFESAVING and RESCUE SERVICES COMMITTEE (LRSC)

4.1 The Lifesaving and Rescue Services Committee (LRSC)

4.1.1 LRSC is authorised by the Constitution of Surf Life Saving Sydney and its membership shall be as defined in By-Law 4.

4.2 The Role of LRSC

- 4.2.1 To assist the Director of Lifesaving & Rescue Services in the implementation of all SLSA and SLSNSW policies relating to lifesaving and Support Services;
- 4.2.2 The LRSC reports to the SLSS Council and to the SLSS BOM via the Director of Lifesaving & Rescue Services or their nominee
- 4.2.3 The LRSC shall be responsible for the development and implementation of the strategic lifesaving business of SLSS. This will be through monitoring, evaluating, reporting, influencing, initiating and determining (within limits of delegated authority) activities and programs designed to meet SLSA objectives
- 4.2.4 The LRSC shall have power to activate matters falling within its orbit of operations provided that specific referrals by the SLSS Council are the subject of recommendations to the SLSS Council for endorsement or otherwise.
- 4.2.5 The LRSC may create and regulate Sub-Committees, to achieve the purposes of the LRSC and SLSS.

4.3 Responsibilities

- 4.3.1 Be responsible for the development and implementation of strategic lifesaving plans aligned with the SLSS Strategic Plan.
- 4.3.2 Review, develop and maintain lifesaving rules, policies, standards and lifesaving manuals for SLSS.
- 4.3.3 Review, develop and maintain the annual patrol obligations for SLSS.
- 4.3.4 Encourage members, groups and teams to realise their potential.
- 4.3.5 Review, develop and conduct lifesaving events for SLSS.
- 4.3.6 Encourage the expansion of services including professional lifeguarding.
- 4.3.7 Attend to matters referred by the SLSS Council or the Board of Management.
- 4.3.8 Shall approve or reject all applications for Lifesaving Service awards submitted by members.

4.4 Composition of LRSC

- 4.4.1 Director of Lifesaving & Rescue Services (who shall act as LRSC chairperson)
- 4.4.2 Manager Lifesaving
- 4.4.3 Manager Rescue Services
- 4.4.4 Area Lifesaving Coordinators (4 positions)
- 4.4.5 ORB Coordinator
- 4.4.6 RWC Coordinator
- 4.4.7 Duty Officer Coordinator
- 4.4.8 UAV Coordinator
- 4.4.9 Emergency Management Coordinator

4.5 Pre-selection of LRSC Officers

4.5.1 Area Lifesaving Coordinators (4.4.4)

4.5.1.1 With the exception of the Director of Lifesaving and Rescue Services, Manager Lifesaving, Manager Support Operations and (LRSC Executive), the Emergency Management Coordinator and the Rescue Services Coordinators, the remaining LRSC positions (4.4.4 i.e. 4 positions) shall be pre-selected for each operational area by officers nominated in by-law 4.5.1.2

Pre-Selection Meetings will be chaired by the Director of Lifesaving and Rescue Services.

Pre-Selection Meetings will be held on the date notified by the Board of Management. Pre-Selected officers are forwarded to the Branch Board of Management for endorsement and then to the Branch Council Election Meeting for election.

- 4.5.1.2 Voting eligibility for the non-executive positions of Lifesaving Coordinator for each Operational area shall be restricted to the Club Captains (holding Club Office at the time of the election).
- 4.5.1.3 A quorum for an election meeting shall be 5 as per the attendance register.
- 4.5.1.4 Voting shall be as determined by the Chairman or by secret ballot if requested by any voting member present.

4.5.2 Appointment of Rescue Services Coordinators

4.5.2.1 The Board of Management will call for expressions of interest from appropriately qualified members, for the four Rescue Services Coordinator positions, referred to in by-laws 4.4.5, 4.4.6, 4.4.7, 4.4.8 and 4.4.9 referred to in by-law 4.4. The Board of Management will consider recommendations from the Director of Lifesaving and Rescue Services and shall appoint one candidate for each position. Those appointments will be considered for endorsement at the Branch Council Election meeting.

4.5.3 Appointment of LRSC Managers

4.5.3.1 The Board of Management will call for expressions of interest from appropriately qualified members, for the two LRSC Manager positions, referred to in by-laws 4.4.2 and 4.4.3 The Board of Management will consider recommendations from the Director of Lifesaving and Rescue Services and appoint one candidate for each position. Those appointments will be considered for endorsement at the Branch Council Election meeting.

4.5.4 Director of Lifesaving & Rescue Services

4.5.4.1 The Director of Lifesaving & Rescue Services will be elected at the Branch Council Election meeting from nominations received from appropriately qualified members.

4.5.6 LRSC Executive Officers

- 4.5.6.1 The LRSC Executive will consist of the Director of Lifesaving & Rescue Services, the Lifesaving Manager, and the Rescue Services Manager.
- 4.5.6.2 The LRSC Executive shall meet the position descriptions contained herein and ensure compliance and alignments with SLSS Branch Strategic Plan.
- 4.5.6.3 The LRSC Executive shall meet as required to decide on matters of urgency between formal LRSC Committee meetings.
- 4.5.6.4 All minutes and decisions shall be ratified by the LRSC.
- 4.5.6.5 A quorum shall be two members of the LRSC Executive

4.6 General

- 4.6.1 The LRSC shall have the authority to co-opt the services of other persons including officers, chairmen of Committees or Sub-Committees to provide advice and/or assistance on specific matters from time to time
- 4.6.2 Visitors and/or observers may attend meetings of the LRSC by prior agreement of the Director of Lifesaving & Rescue Services
- 4.6.3 In the event of the absence of the Director of Lifesaving the Board of Management shall appoint one of Executive to act during such absence.
- 4.6.4 Additional positions may be appointed to the LRSC by the LRSC. However, they shall not be entitled to a vote on any matter

4.7 Meetings of the LRSC Committee

- 4.7.1 LRSC meetings shall be held monthly; or
- 4.7.2 As directed by the SLSS Council or SLSS BOM.
- 4.7.3 Meetings may be face to face or by other means of telecommunications.
- 4.7.4 LRSC and EC shall hold a minimum of three joint meetings during the year. Agenda items for each meeting shall be proposed by each Director and a quorum of shall be six. Minutes of the joint meetings will require the endorsement of both LRSC and EC. The chairperson will alternate between DLRS and DE.

4.8 Quorum

4.8.1 The quorum for any LRSC meeting shall be at least five (5) members, who are entitled to vote.

4.9 Voting

4.9.1 All listed members as provided for in By-Law 4.4, including the LRSC Chairperson, shall be entitled to one (1) vote only on any resolution at all meetings of the LRSC at which they are present in person or by alternate. In the case of a tied ballot, the LRSC Chairperson has a further casting vote.

4.10 Minutes

- 4.10.1 The Director of Lifesaving & Rescue Services or their nominee, shall cause full and accurate Minutes of the LRSC Committee meetings to be recorded. The Director shall be responsible for the compilation and distribution of such minutes.
- 4.10.2 The Minutes of the LRSC meeting shall be promptly distributed to members of the LRSC and the BOM.

4.11 LRSC Standing Sub Committees

4.11.1 Rescue Services Sub-Committee

4.11.1.1 The Rescue Services Committee shall comprise the following members: -

Manager Rescue Services (Chairperson)

ORB Coordinator

RWC Coordinator

Duty Officer Coordinator

UAV Coordinator

Youth Lifesaving Coordinator

Junior Lifesaving Manager

Director of Lifesaving & Rescue Services (Ex-officio)

- 4.11.1.2 Be responsible to the Director of Lifesaving & Rescue Services and the LRSC for the correct operation of Groups within its scope such as RWC, ORB, UAV and Duty Officers.
- 4.11.1.3 Develop and implement the delivery of support operations services throughout the Branch.
- 4.11.1.4 Discuss issues relating to Rescue Services and submit recommendations to the LRSC.
- 4.11.1.5 Meet regularly or as directed by the Director of Lifesaving & Rescue Services through the Manager Rescue Services.
- 4.11.1.6 The Manager Rescue Services shall ensure minutes of all meetings are taken and that these are presented to the LRSC for adoption.
- 4.11.1.7 The Manager Rescue Services shall ensure that the list of active members of groups within Rescue Services is maintained and proper records are being kept including contact details, log books, patrol hours and asset lists

4.11.2 Patrol Tribunal Sub-Committee

4.11.2.1 The Patrol Tribunal Sub-Committee shall comprise the following members:

Director of Lifesaving & Rescue Services (Chairperson)

Manager Lifesaving

Manager Rescue Services

Relevant District Coordinator (Lifesaving)

- 4.11.2.2 The Patrol Tribunal shall be formed to investigate and make recommendation relating to failure of a Club or Group to meet the minimum patrol standards or any other issue relevant to Lifesaving as required.
- 4.11.2.3 Three shall form a quorum. In the event that one of the members is absent, the Director of Lifesaving & Rescue Services (or, in their absence, their Deputy) can appoint the LRSC Secretary or an alternative LRSC Officer to fill the committee.
- 4.11.2.4 The Patrol Tribunal shall be formed to investigate an issue at the direction of the LRSC and ensure that the accused party is given an opportunity to present information relating to the issue at hand.
- 4.11.2.5 The Patrol Tribunal shall only have the power to make recommendations to the LRSC and if confirmed make these recommendations to the SLSS Council for action.
- 4.11.2.6 The Chairperson shall point one of the Committee to take minutes and ensure these are presented to the LRSC for adoption.

4.11.3 Lifesaving Sub-Committee

4.11.3.1 The Lifesaving Sub-Committee shall comprise the following members:-

Lifesaving Manager (Chairperson)

The 4 operational area Lifesaving Coordinators

Director of Lifesaving & Rescue Services (ex officio)

- 4.11.3.2 Three shall form a quorum.
- 4.11.3.3 The Lifesaving Sub-Committee shall meet as required at the direction of the Lifesaving Manager.
- 4.11.3.4 Through the Lifesaving Manager the Lifesaving Sub-Committee shall ensure that the Gear Inspection and the Patrol Inspection processes are coordinated correctly and that the results are presented to the LRSC for approval.
- 4.11.3.5 The Lifesaving Sub-Committee shall meet and discuss all issues pertaining to the required patrolling standard and make recommendations to the LRSC relating to any remedy or issue as required.
- 4.11.3.6 The Lifesaving Manager shall be responsible to ensure that minutes of meetings are kept and presented to the LRSC for adoption.

4.12 Left vacant deliberately

4.13 Manager Lifesaving

4.13.1 Qualifications

- 4.13.1.1 Shall hold a certificate II Aquatic Rescue (Aquatic Rescue) (Bronze Medallion)
- 4.13.1.2 Shall have a proven knowledge and ability in Lifesaving Operations

BY-LAW 5 THE EDUCATION COMMITTEE

5.1 The Education Committee (EC) is authorised by the Constitution of Surf Life Saving Sydney and its membership shall be as defined in By-Law 5.

5.2 The Role of EC

- 5.2.1 To assist the Director of Education in the implementation of all SLSA and SLSNSW policies relating to Education and Training;
- 5.2.2 The EC reports to the SLSS Council and to the SLSS BOM via the Director of Education or their nominee
- 5.2.3 The EC shall be responsible for the development and implementation of the strategic education business of SLSS. This will be through monitoring, evaluating, reporting, influencing, initiating and determining (within limits of delegated authority) activities and programs designed to meet SLSA objectives.
- 5.2.4 The EC shall have power to activate matters falling within its orbit of operations provided that specific referrals by the SLSS Council are the subject of recommendations to the SLSS Council for endorsement or otherwise.
- 5.2.5 The EC may create and regulate Sub-Committees, to achieve the purposes of the EC and SLSS.

5.3 Responsibilities

- 5.3.1 Be responsible for the development and implementation of strategic education plans aligned with the SLSS Strategic Plan.
- 5.3.2 Review, develop and maintain education rules, policies, standards and manuals for SLSS.
- 5.3.3 Review, develop and maintain the annual training and assessment obligations for SLSS.
- 5.3.4 Encourage members, groups and teams to realise their potential.
- 5.3.5 Review, develop and conduct education events for SLSS.
- 5.3.7 Attend to matters referred by the SLSS Council or the Board of Management.
- 5.3.8 Shall approve or reject all applications for Education Service awards submitted by members

5.4 Composition of EC Committee

- 5.4.1 Director of Education (who shall act as EC chairman)
- 5.4.2 Manager Branch Education
- 5.4.3 Area Education Coordinators (4 positions)
- 5.4.4 Youth Education Coordinator
- 5.4.5 Junior Education Manager

5.5 General

- 5.5.1 The EC shall have the authority to co-opt the services of other persons including officers, chairmen of Committees or Sub-Committees to provide advice and/or assistance on specific matters from time to time
- 5.5.2 Visitors and/or observers may attend meetings of the EC by prior agreement of the Director of
- 5.5.3 Additional positions may be appointed to the EC by the EC. However, they shall not be entitled to a vote on any matter

5.6 Meetings of the EC Committee

- 5.6.1 EC meetings shall be held monthly; or
- 5.6.2 As directed by the SLSS Council or SLSS BOM.
- 5.6.3 Meetings may be face to face or by other means of telecommunications.

5.6.4 LRSC and EC shall hold a minimum of three joint meetings during the year. Agenda items for each meeting shall be proposed by each Director and a quorum of shall be six. Minutes of the joint meetings will require the endorsement of both LRSC and EC. The chairperson will alternate between DLRSC and DF.

5.7 Quorum

5.7.1 The quorum for any EC meeting shall be at least four (4) members, who are entitled to vote.

5.8 Voting

5.8.1 All listed members as provided for in By-Law 4.4, including the EC Chairman, shall be entitled to one (1) vote only on any resolution at all meetings of the EC at which they are present in person or by alternate. In the case of a tied ballot, the EC Chairman has a further casting vote.

5.9 Minutes

- 5.9.1 The Director of Education, or their nominee, shall cause full and accurate Minutes of the EC Committee meetings to be recorded. The Director shall be responsible for the compilation and distribution of such minutes.
- 5.9.2 The Minutes of the EC meeting shall be promptly distributed to members of the EC and the BOM.

5.10 Pre-selection of EC Officers

5.10.1 Education Coordinators

5.10.1.1 With the exception of the Director of Education and Manager Branch Education, the remaining EC positions (4 positions) shall be *pre-selected by each operational area by officers nominated in by-law 5.10.1.2.

Pre-Selection Meetings shall be chaired by the Director of Education.

Pre-Selection Meetings will be held on the date notified by the Board of Management. Pre-Selected officers are forwarded to the Branch Board of Management for endorsement and then to the Branch Council Election Meeting for election.

- 5.10.1.2 Voting eligibility for the positions of Education Coordinator for each Operational area shall be restricted to Branch Assessors (see 5.8), Club Captains and Chief Instructors (holding Club Office at the time of the election).
- 5.10.1.3 A quorum for an election meeting shall be 8 as per the attendance register.
- 5.10.1.4 Voting shall be as determined by the Chairman or by secret ballot if requested by any voting member present.

5.11 Appointment of Manager Branch Education

5.11.1 The Board of Management will call for expressions of interest from appropriately qualified members, for the Manager Branch Education position, referred to in by-law 5.12 The Board of Management will consider recommendations from the Director of Education and appoint a candidate to the position. Those appointments will be considered for endorsement at the Branch Council Election meeting.

5.12 Director of Education

5.12.1 The Director of Education will be elected at the Branch meeting from nominations received from appropriately qualified members.

BY-LAW 6 SURF SPORTS COMMITTEE

6.1 Surf Sports Committee (SSC)

6.1 The Surf Sports Committee (SSC) is authorised by the Constitution of Surf Life Saving Sydney and its membership is defined in these By-Laws. The Surf Sports Committee shall be chaired by the Director of Surf Sports. Duties and responsibilities shall be as follows.

6.2 SSC Charter

- 6.2.1 The SSC reports to the SLSS Council and to the SLSS Board of Management via the Director of Surf Sports or their nominee.
- 6.2.2 The SSC shall be responsible for the development and implementation of the surf sport competition and activities of SLSS. This will be through monitoring, evaluating, reporting, influencing, initiating and determining (within limits of delegated authority) activities and programs designed to meet SLSS objectives.
- 6.2.3 The SSC shall have power to activate matters falling within its orbit of operations provided that specific referrals by the Council are the subject of recommendations to the Council for endorsement or otherwise.
- 6.2.4 The SSC may formulate and monitor Sub-Committees, to achieve the purposes of the SSC and SLSS.

6.3 SSC Responsibilities

The responsibility of the Surf Sports Committee is to: -

- 6.3.1 Supervise and ensure that the conduct of all surf sports competition and special events conducted by SLSS follow the current SLSA Surf Sports Manual.
- 6.3.2 Promote forward thinking in surf sports, ensure member protection and that SLSS guidelines are followed.
- 6.3.3 Report to the SLSS Council on all matters, progress, developments and agendas of the Surf Sports Committee.
- 6.3.4 Be responsible for the development and implementation of surf sport competition and activities align with the SLSS Strategic Plan.
- 6.3.5 Review, develop and maintain surf sport rules, policies, standards and surf sport manuals for SLSS.
- 6.3.6 Review, develop and maintain surf sport competition and obligations for SLSS.
- 6.3.7 Encourage members, groups and teams to realise their potential.
- 6.3.8 Review, develop and conduct surf sport events for Surf Life Saving Sydney.
- 6.3.9 Appoint relevant sub-committees to assist the SSC to fulfill its obligations.
- 6.3.10 Provide ongoing education and development of competition officials.
- 6.3.11 Attend to matters referred by the Council or other Boards.

6.4 Composition of Surf Sports Committee (SSC)

The SSC Committee (Executive) officers shall comprise: Director of Surf Sports (who shall act as SSC chairperson)
Deputy Director of Surf Sports
Senior Competition Manager
Junior Surf Sports Manager
Youth Surf Sports Coordinator
Administration Manager

The SSC shall have the authority to co-opt the services of other persons including officers, chairpersons of committees or sub-committees to provide advice and/or assistance on specific matters from time to time. In particular, the SSC will call annually for expressions of interest for persons to fill the following advisory roles: Interbranch Team Coordinator (by-law 6.5), Coaching Coordinator (by-law 6.6), Officials Coordinator (by-law 6.7), Assistant Competition Manager (by-law 6.8), Equipment Coordinator (by-law 6.9), Watercraft and IRB Coordinator (by-law 6.10), Technical Advisor (by-law 6.11), Surf Boat Coordinator (by-law 6.12), R&R Coordinator (by-law 6.13), March Past Coordinator (by-law 6.14), Pool Advisor (by-law 6.15), Safety and Risk Management Coordinator (by-law 6.16) and Board Riding Coordinator (by-law 6.17). 

 - Members of the Surf Sports Committee-Sub Committee (defined in 5.20)
- 6.18.2 A quorum for an election meeting shall be 10 as per the attendance register
- 6.18.3 The meeting procedure shall be similar to the SLSS Council Election Meeting
- 6.18.4 The SSC Officers shall be elected for a twenty-four month term. The Deputy Director of Surf Sports, Senior Competition Manager and Administrative Manager will be elected in even numbered years. The Junior Surf Sports Manager will be elected in odd numbered years.

6.19 SSC Meetings General

- 6.19.1 Visitors and/or observers may attend meetings of the Surf Sports Committee by prior agreement of the Director of Surf Sports.
- 6.19.2 In the event of the absence of the SSC Chairman, the meeting shall be chaired by the Deputy Director of Surf Sports. In the event that the Director and Deputy Director are both absent, the meeting shall appoint one of its members to act during such absence.
- 6.19.3 SSC meetings shall be held monthly, or as directed by the SLSS Council or SLSS Board of Management.
- 6.19.4 SSC meetings may be face to face or by other means of telecommunications.
- 6.19.5 The quorum for any Surf Sports Committee meeting shall be at least three (3) members entitled to vote.
- 6.19.6 Voting; All listed members as provided for in By-Law 6.4, including the SSC Chairman, shall be entitled to one (1) vote only on any resolution at all meetings of the SSC Committee at which they are present in person or by alternate. In the case of a tied ballot, the SSC Chairman has a further casting vote.
- 6.19.7 SSC Meeting Minutes; The Director or their nominee shall cause full and accurate Minutes of the SSC meetings to be recorded.
- 6.19.8 The Minutes of the SSC meeting shall be promptly distributed to members of the SSC Officers and Surf Life Saving Sydney BOM.

6.20 Surf Sports Sub-Committee

The Surf Sports Sub-Committee shall comprise all carnival officials who are bona fide members of clubs and have filled in the appropriate renewal form as laid down by the SSC each season and have met any other criteria required by the SSC for membership.

BY-LAW 9 CONSTITUTION COMMITTEE

- 9.1 A committee of three persons shall be elected at the SLS Sydney Annual Election Meeting in addition to the SLS Sydney Director of Administration/Chief Executive Officer as ex-officio and non-voting.
- 9.2 All matters affecting the Constitution of SLS Sydney shall be referred to this committee for consideration and report to the SLS Sydney Council.
- 9.3 Recommendations, which involve alteration in the SLS Sydney Constitution, shall be given effect as provided in the Constitution.
- 9.4 Two (2) elected members shall form a quorum.

BY-LAW 10 FINANCE AND COMPLIANCE COMMITTEE

- 10.1 A Committee of five (5) full members and associate members made up as follows:
 - 10.1.1 The SLSS Director of Finance,
 - 10.1.2 Two (2) members from clubs who shall be elected at the SLSS Annual Election Meeting,
 - 10.1.3 Two (2) members appointed by the BOM who do not need to be from clubs, and
 - 10.1.4 Further associate members, appointed by the Director of Finance, from clubs not represented from the members at 10.1.2 and 10.1.3 of the Committee. Associate Members are welcome to contribute to discussion although do not have a vote on the Committee.
- 10.2 All members of the Committee must
 - 10.2.1 Be financially literate, and have experience in a financial setting, being able to read financial statements and challenge financial information presented.
 - 10.2.2 Be free of any conflict of interest. Members must act in the interests of the Branch ahead of their own respective Surf Club
- 10.3 Of the committee members:
 - 10.3.1 One (1) from 10.1.2 and 10.1.3 shall be appointed to the position of Assistant Director of Finance by the BOM note that the Assistant Director of Finance must be a Member of an Affiliated Club (in accordance with the constitution). The Assistant Director of Finance shall assist the Director of Finance with duties as detailed by these By-Laws. It is the intention that the Assistant Director of Finance be the eventual successor of the Director of Finance and will therefore be trained accordingly and will undertake some of the duties of the Director of Finance over time to facilitate a smooth handover.
 - 10.3.2 One (1) from 10.1.3 shall be appointed as 'Financial Advisor'. The Finance Advisor shall provide advice to the Finance and Compliance Committee and will chair the Finance and Compliance Committee meetings. The Financial Advisor shall have voting rights. The Financial Advisor shall hold formal

qualifications (as determined by the BOM). It is also the intention that the Financial Advisor be a previous Director of Finance to mentor the incoming Director or Finance.

- 10.4 Three (3) full members shall form a quorum.
- 10.5 The Finance and Compliance Committee is to meet no less than three (3) times a year as identified:
 - 10.5.1 One of these meetings is to review the annual budget,
 - 10.5.2 One of the meetings is to review the annual financial statements, and
 - 10.5.3 One meeting is to undertake a mid-season review of performance against budgets.
 - 10.5.4 Additional meetings may be called by the Director of Finance in consultation with the Financial Advisor.
- 10.6 The Finance and Compliance Committee shall:
 - 10.6.1 Review the annual budget prepared by the Director of Finance each season in conjunction with the Directors and Managers.
 - 10.6.2 Present the budget to the SLSS President and advise the BOM of any concerns.
 - 10.6.3 Review investments of the Branch and advise the BOM of any concerns.
 - 10.6.4 Ensure that the asset register is kept up to date.
 - 10.6.5 Review charges annually and advise the BOM.
 - 10.6.6 Review the annual financial statements and audit opinion.
 - 10.6.7 Assist in reviewing sponsorships for the Branch.
 - 10.7 Act as a networking forum for the Finance staff from Surf Clubs across the Branch

BY-LAW 11 COMPETITION SELECTION COMMITTEE

- 11.1 A Committee consisting of the Director of Surf Sports and four others shall be elected at SLSS Annual Election Meeting and they shall be responsible for the selection of SLSS Teams, and any other teams referred to them by SLSS. The meeting will be chaired by the Director of Surf Sports.
- 11.2 The Committee shall report their findings to the first following meeting of SLSS Council or SLSS BOM.
- 11.3 Three (3) elected members shall form a quorum.

BY-LAW 12 SUB-COMMITTEES

- 12.1 The SLSS Council and each Standing Committee may appoint select committees at any given time unless otherwise directed by Council, each comprising up to seven (7) members to advise on matters relevant to a particular requirement.
- Such select committee shall be responsible to the appointing Committee and will receive administrative support from the Director of Administration/Chief Executive Officer or their nominee; and meet to consider matters referred by the various Committees and within the guidelines set.
- 12.3 A chairman, nominated by the SLSS Council or appointing Committee shall represent the subcommittee when and where directed.

BY-LAW 13 LIFE MEMBERSHIP AND HONOURS COMMITTEE

- 13.1 A Committee of seven (7) members shall be elected at SLSS Annual General Meeting and shall consider all nominations for Life Membership. Presidents Medal and Honours
- 13.2 The elected members of the Committee shall:-
- 13.2.1 Be representative of at least four (4) Affiliated Clubs
- 13.2.2 Comprise at least three (3) members who shall be SLSS Life Members
- 13.2.3 Comprise of at least two (2) members who are members of the SLSS Lifesaving and Education Committee and two (2) members who are members of the SLSS Surf Sports Committee.
- 13.3 The Director of Administration and the Director of Members Services shall be ex-officio members of the Life Members and Honours Committee with full voting rights.
- 13.3.1 Chairperson of the Life Members and Honours Committee will be by the Director of Administration or The Director of Member Services.
- 13.3.2 The Chairperson shall be responsible for keeping confidential records of the meeting
- 13.4 Five (5) members of Committee shall form a quorum

BY-LAW 14 JUDICIARY COMMITTEE AND DISCIPLINARY MATTERS

- 14.1 Surf Life Saving Australia Limited Constitution and Policies shall be followed in relation to any and all meetings called to conduct disciplinary or judicial proceedings or the like proceedings in relation to the conduct of a club, a member or group of members.
- The SLS Constitution used in any disciplinary or judicial proceeding shall be the constitution that is current at the time that the incident or incidents took place, additionally; it shall be the constitution that is current at the time that the last incident of all incidents under review took place.

BY-LAW 15 HONORARY LEGAL ADVISORY PANEL

- 15.1 An Honorary Legal Advisory Panel shall be appointed by the SLSS Board of Management and endorsed by the SLSS Council for the purpose of providing counsel to SLSS Council and SLSS BOM on legal matters. The number of members of the Honorary Legal Advisory Panel shall be determined by the Board of Management.
- 15.2 The Honorary Legal Advisory Panel shall be:
- 15.2.1 members of SLSS affiliated clubs; and
- 15.2.2 either solicitors or barristers of good standing who possess current legal practicing certificates.
- 15.3 The members of the Honorary Legal Advisory Panel shall report to the Chief Executive Officer, or in the absence of a Chief Executive Officer, the Director of Administration.
- 15.4 The members of the Honorary Legal Advisory Panel may be called upon by the Chief Executive Officer or the Director of Administration to, where possible:
 - Provide general legal insight into issues raised by the SLSS Council and BOM;
 - Provide SLSS Council and SLSS BOM with legal advice where possible; and
 - Suggest suitable legal advisors to answer specialised legal questions.
- 15.5 The members of the Honorary Legal Advisory Panel shall be selected for a term of up to three (3) years.

BY-LAW 16 UNBECOMING CONDUCT (at meetings)

Any Officer or Delegate guilty of objectionable language or unbecoming conduct at any SLSS meeting, may be called upon by the Chairman of the meeting to retract and apologise for same, or may be dealt with as SLSS thinks fit. Such Officer or Delegate shall, if required by the meeting, retire whilst his conduct is being discussed.

BY-LAW 17 ASSESSMENTS, CARNIVALS, SURF SPORTS COMPETITIONS & DISPLAYS

- 17.1 SLSS shall have power to regulate all assessments, carnivals, surf sports competitions and displays within SLSS, provided that in all Club and interclub competitions, the rules of SLSA and general rules for competition as set out in the Surf Life Saving Australia Ltd Competition Manual, are complied with.
- 17.2 SLSS shall have power to allocate any carnival, surf sports competition or display to any Club and to appoint Officers to control same. No interclub carnival, surf sports competition or display shall be held without the approval of SLSS.
- 17.3 SLSS shall determine, as soon as practicable, a program of carnivals, surf sports competitions and displays for the forthcoming season.
- 17.4 Clubs shall apply to SLSS to conduct such carnivals, surf sports competitions and displays and those Clubs that are successful with a nomination, shall be allocated a specific date on the program.
- 17.5 No Club shall negotiate or commence to organise a carnival, surf sports competition or display which will involve the participation of Branch members and which will conflict with the scheduled program without first making formal application to SLSS.
- 17.6 The Surf Sports Committee will appoint Referees, Judges and other officials and may make rules respecting their powers and duties.
- 17.7 SLSS may appoint as an official (other than those accredited) any person (whether a member of the Association or not) provided that it is satisfied that such person has special knowledge qualifying them for such position, and any such person so appointed shall thereupon be considered to be a member of SLSS for the time they occupy such position.

BY-LAW 18 COMPETITION OUTSIDE SURF LIFE SAVING SYDNEY

- 18.1 No Individual Member or Club shall take part in any carnival, surf sports competition or display conducted by any other surf life saving authority, person or organisation, unless such Individual Member or Club has first obtained the prior permission of SLSS.
- 18.2 A responsible Manager must accompany members of a Club visiting other Clubs outside SLSS.

BY-LAW 19 BRANCH COSTUME, BLAZER, AND BADGE,

- 19.1 The Sydney Branch blazer shall be of a design as approved by SLSS.
- 19.2 Only Officers, Assessors and Facilitators of SLSS, or such other persons as may be approved by SLSS as being persons who have rendered distinguished service to SLSS, shall be eligible to wear the badge of SLSA on the blazer pocket. No SLSS blazer shall be obtained by any member except on the written order of the Director of Administration/Chief Executive Officer.
- 19.3 SLSS carnival costume and costume badge and coat badge shall be of a design as approved by SLSS.

BY-LAW 20 NON-PARTY POLITICAL AND NON-SECTARIAN

20.1 SLSS shall be strictly non-party political and non-sectarian and shall not directly or indirectly allow any subject bearing on politics or religion to be introduced at any meeting of SLSS or within SLSS

premises. Any member of SLSS who publicly participates in any political gathering or meeting, shall not act as if they represented the views of SLSS.

BY-LAW 21 RULES OF DEBATE

- 21.1 Any member desiring to speak shall stand up and shall address the Chairman respectfully.
- 21.2 No member may speak more than once to a question, except in explanation or reply.
- 21.3 A member, who formally seconds a motion or amendment, may address the meeting in support at a subsequent stage of the debate.
- 21.4 A reply shall be allowed only to a member who has moved a substantive motion.
- 21.5 No member shall use offensive or unbecoming words.
- 21.6 No speaker shall digress from the subject under discussion, and impure, improper motives and all personal reflections on members shall be deemed disorderly.
- 21.7 Whenever the Chairman rises during debate, the member then speaking shall sit down.
- 21.8 No member shall interrupt another while speaking, except on a point of order.
- 21.9 Any member during the debate may raise the point of order, when the member then speaking shall sit down until the point of order has been decided. The member rising to the point of order shall state concisely the point, and the Chairman without further discussion shall give his ruling.
- 21.10 It shall be competent for any member to move a motion of dissent from the Chairman's ruling. The mover of the motion of dissent shall concisely state his point. The seconder and the Chairman only may speak to the motion.
- 21.11 A member may move the adjournment of the debate. If the motion be resolved in the negative, the mover shall not be allowed to again speak on the question under debate. If the motion be resolved in the affirmative, the mover shall have the right of resuming the debate at the ensuing meeting. No member shall move the adjournment at the end of his speech.
- At any time during the debate, any member may without motive move "that the question now be put" and such motion being duly seconded, shall then be put without debate. If carried, the question shall be put to the vote; if lost, the debate shall proceed.
- 21.13 An amendment may be moved on any original motion. The Chairman shall first put the amendment to the meeting and if carried, it shall be declared to embody the decision of the meeting superseding the motion. When an amendment has been decided, a further amendment may be moved, which, if carried, shall in turn supersede the motion. If there be no amendment, the original motion shall be put after the mover has replied.
- 21.14 The Chairman shall refuse to receive any amendment, which is a direct negative.
- 21.15 In the event of any matter being brought before any Annual or General Meeting, which affects the Chairman of the meeting, or in which he may be interested, he shall vacate the Chair and the meeting shall elect a Chairman protem until such matter is dealt with.
- 21.16 Voting shall be by the voices, or show of hands at the request of any member.
- 21.17 If a secret ballot is demanded at any meeting by two members who are present thereat, it shall be taken upon such conditions as the Chairman of such meeting directs.
- 21.18 The Chairman may appoint tellers to assist him in counting a vote by show of hands or division, or at a secret ballot.
- 21.19 The mover of an original motion must obtain the consent of his seconder and the approval of the meeting before making any alteration to the wording of his motion.
- 21.20 An amendment having been moved, it shall not be competent to move any further amendment but notice may be given of intention to move such further amendment when the previous amendment has been disposed of. Only one amendment can be considered at the one time.

21.21 In the absence of the President and Deputy President, the Chairman of that meeting shall be elected by vote of the members in attendance thereat.

BY-LAW 22 COMMUNICATIONS

- 22.1 All communications, internal and external, shall be distributed as authorised by the Director of Administration or their nominee.
- A *Digital / IT Manager* and a *Social Media Manager* may be appointed by the BOM following expressions of interest sought from SLSA members and may be appointed for a 24-month term. Both 22.2 positions will report directly to the Director of Administration. Qualifications for these positions will be determined by the Director of Administration as required from time to time.
